

REVISION ORDER UNDER SECTION 32 OF THE FCRA, 2010

Whereas Navsarjan Trust, 2, Ruchit Apartments, Behind Dharnidhar Derasar, Vasna, Ahmedabad, Gujarat (hereinafter referred as the said association) was registered under Foreign Contribution (Regulation) Act, 1976 (now FCRA,2010) to receive Foreign Contribution for Educational, Social purpose vide this Ministry Registration no. 042040075R;

2. And whereas, the said Association submitted online application for renewal of registration certificate on 27.02.2016 as per provisions of Section 16 of FCRA, 2010 read with rule 12 of FCRR, 2011, (as amended from time to time);

3. And whereas, said association has come to adverse notice for its undesirable activities aimed to affect prejudicially harmony between religious, racial, social, linguistic, regional groups, castes or communities;

4. And whereas, as per revised internal guidelines dated 14.12.2015 and FCRA, 2010, any association who has come to adverse notice for activities detrimental to national interest, cannot be granted renewal of registration certificate;

5. And whereas, one of the conditions for granting registration under Section 12(4) of the FCRA, 2010 is that the acceptance of foreign contribution by the person is not likely to affect prejudicially harmony between religious, racial, social, linguistic, regional groups, castes or communities;

6. And whereas the association has also come to notice for violation of provisions of Section 8 of FCRA, 2010;

7. And whereas, the application for renewal of registration submitted by the said association ought to have been refused under Section 12(4) (f)(vi) and Section 16 of the FCRA, 2010 but registration certificate of the said Association was renewed inadvertently by the concerned officer of FCRA Wing of the Foreigners Division;

8. And whereas there is need to revise the said order for renewal of registration in public interest;

9. And whereas, the proceedings of the case were called for, to examine the case relating to passing of the renewal order and it has been found that this is a fit case for revision of the said order for renewal;

9. Therefore, the competent authority in the Ministry of Home Affairs has, in exercise of powers under section 32 of the Foreign Contribution (Regulation) Act, decided to revise the order 03.08.2016 to renew the FCRA registration of Navsarjan Trust, 2, Ruchit Apartments, Behind Dharnidhar Derasar, Vasna, Ahmedabad, Gujrat The renewal order dated 03.08.2016 shall be non-est ab-initio.
