NOTIFICATION

New Delhi, the 16th June, 2006

S.O. 924(E):- Whereas associations registered under the Foreign Contribution (Regulation) Act, 1976 (49 of 1976), are required to furnish intimation about the acceptance, source, manner and utilization of foreign contribution in the prescribed manner and within the prescribed period.

And whereas a large number of associations had failed to furnish accounts pertaining to three years namely 2001-02, 2002-03, and 2003-04 and thereby contravened the provisions of sub-section (l) of section 6 of the said Act read with clause (a) of rule 4 of the Foreign Contribution (Regulation) Rules, 1976 made thereunder;

And whereas after following the due process of law, the Central Government, in exercise of the powers conferred by the proviso to sub-section (1) of section 6 of the said Act had placed these associations in the prior permission category, vide notification number S.O.1621 (E) published in the Gazette of India, Part-II-Section 3, Sub-section(ii) dated the 18th November, 2005;

And whereas on the basis of representations received from some of the associations, it is noticed that some organizations have submitted the prescribed accounts, some have submitted proof of sending or furnishing of accounts for the relevant period alongwith the copies of accounts and some of them, have either obtained or were granted multiple registration numbers, had been submitting annual accounts for only one of these multiple registration numbers;

Now, therefore, after due consideration, the Central Government, in exercise of the powers conferred by section 31 of the said Act hereby orders that such associations, which submit proof of submission of the prescribed annual accounts for three years, that is, 2001-02, 2002-03 and 2003-04 along with the copies of the accounts, or submit proof of having multiple registration numbers and having submitted returns for one of those which is operational, or have since furnished or now furnish on or before 31st December, 2006, annual accounts for the said period shall stand exempted from the said notification. In the case of multiple registration numbers, the registration for which accounts are not being submitted shall stand deleted from records after proof for such multiple registration is submitted.
