**ORDER**

Whereas, the association, **The United Theological College, 63, Miller's Road, Benson Town, Bangalore – 560 046**, is registered under the Foreign Contribution (Regulation) Act, 2010 vide Regn No. **094420072R**;

Whereas, it has been found during an on-site inspection of accounts and records conducted on 15-17<sup>th</sup> September, 2014 that the association has transferred foreign contribution to local accounts ;

Whereas the association has invested in Shares & Mutual Funds which are speculative investments;

Whereas the association has received foreign contribution in accounts other than designated Foreign Contribution Bank account;

Whereas the association has not placed the summary data of receipt and utilisation of foreign contribution in the public domain;

Whereas the students of the college being run by the association has participated in anti-posco agitation, as is evident from their minutes book;

And thereby the association has violated the provisions contained in Section 17(1), 12(4)(v) and 12(4)(iv) of Foreign Contribution (Regulation) Act, 2010 read with rule 4 and 13 of Foreign Contribution (Regulation) Rules, 2011;

And whereas, the Central Government having regard to the information and evidence in its possession is satisfied that the acceptance of foreign contribution by the said Association The United Theological College, 63, Miller's Road, Benson Town, Bangalore – 560 046, is likely to prejudicially affect the public interest;

Now, therefore, in exercise of the power conferred by Section 13 of the Foreign Contribution (Regulation) Act, 2010, the Central Government hereby temporarily suspends, in public interest, the registration under FCRA, 2010 of the association The United Theological College, 63, Miller's Road, Benson Town, Bangalore – 560 046, (including its branches and units) for a period of one hundred and eighty days with effect from the date of this order.
